1. Place and purpose of the discipline in the structure of the HPE

The discipline "Decision-making process" belongs to the elective disciplines of the educational component of the graduate program and is studied in the second year of study in the fourth semester.

The purpose of the discipline - to deepen knowledge about the development and implementation of managerial public decisions, the development of skills in the development and practical implementation of management decisions.

Planned learning outcomes for the discipline

Know:

- types of government decisions and methods of making them;
- decision-making mechanisms of state and municipal authorities;
- methods for evaluating the results of management decisions.

To be able to:

- apply methods of diagnosis and analysis of problem situations;
 - To exercise adequate managerial influence on socio-economic and political processes, social groups and organizations to overcome social problems;
- identify typical algorithms for decision-making in the civil service.

Own:

- skills in developing management decisions;
- skills in organizing decision-making in state and municipal authorities;
 - skills to apply managerial influence on socio-economic and political processes, social groups and organizations.

The volume of the discipline (module) is 2 s.e., total - 72 hours, of which 35 hours of contact work of a student with a teacher (seminar type classes - 35 hours), 37 hours is independent work of a student.

5.1. Criteria and procedures for assessing learning outcomes in the discipline

The following basic criteria are taken into account for all work:

- the level of theoretical knowledge (not only the formal reproduction of information, but also the understanding of the subject, which is confirmed by correct answers to additional, clarifying questions posed by the committee members);
- Ability to use theoretical knowledge in the analysis of specific problems and situations;
 - quality of presentation, i.e. the validity, clarity, and logic of an answer, as well as its completeness (i.e. its content, not excluding conciseness);
- the ability to make intra- and interdisciplinary connections,
- originality of thought, familiarity with additional literature, and other factors.

 - c) development of options, evaluation and comparison of options, probability of realization of alternatives and their effectiveness, choice of solution;
 - d) selection of goals, criteria for solution implementation, development of options, approval of the optimal variant.
- The specific situation when making a decision is evaluated:
 - a) by reliability of information, by controllability, by resources, by problem-solving complexity;
 - b) on the solvability of the situation, the ability of staff to find ways and means of solving the problem;
 - c) by technique, by technology, by time, by efficiency in terms of human, material and information resources;
 - d) the complexity and solvability of the problem, resources and motivation of the personnel.

Topic 3: Test Examples of Questions

- The organization of the implementation of the management decision includes:

- (a) Drawing up the decision, informing the executors as far as they are concerned, and strictly enforcing it;
 - b) drawing up a plan for the implementation of the decision with the identification of specific performers and timelines for implementation;
 - c) promoting the decision, mobilizing the team, coordinating the implementation of the decision, regulating and adjusting;
 - d) approval of the decision, an implementation plan and strict control over the implementation of the decision by the steps developed in the plan.
- The greatest effect in making important management decisions gives:
 - (a) A combination of experience, knowledge, intuition of the manager and modern technologies for the development and adoption of management decisions;
 - b) a combination of intuition and the manager's job description;
 - c) a combination of knowledge of the manager and technology to develop and make a management decision.
