### 1. Place and purpose of the discipline in the structure of the PA

The discipline "(Problems of formation of civil society)" belongs to the number of elective disciplines of the educational component of the postgraduate programme and is studied in the 2nd year of study in the 4th semester.

*The objectives of the discipline* "Problems of Civil Society Formation" are to develop skills of correct application of theoretical and legislative provisions of the civil process, to develop skills and abilities to independently analyse and solve social problems with the resources of civil society.

### 3. Structure and content of the discipline.

The volume of the discipline (module) is 2 credit units, a total of 72 hours, of which 32 hours is the contact work of the student with the teacher (lecture type classes - 0 hours, seminar type - 32 hours), 40 hours is independent work of the student.

#### **4. Forms of organisation and control of independent work of students**

#### **5. Fund of assessment means for certification on discipline**

##### **5.1. Criteria and procedures for assessing learning outcomes of the discipline.**

The following basic criteria shall be considered for all work:

- the level of theoretical knowledge (it implies not only formal reproduction of information, but also understanding of the subject, which is confirmed by correct answers to additional, clarifying questions);
- ability to use theoretical knowledge in analysing specific problems and situations;
- The quality of the presentation of the material, i.e. the reasoning, clarity, logic of the answer, as well as its completeness (i.e. content, not excluding brevity);
- the ability to make intra- and inter-subject links,
- originality of thinking, familiarity with additional literature,
- creativity and other factors.

***Description of the assessment scale for the interim assessment in the form of credit***

**5.2. Examples of typical control tasks or other materials used to assess the learning outcomes of the discipline**

*The assignment for the current control is.  
essay "Civil Society in the Mirror of Sociology".*

*Structure of the essay:* a sociological interpretation of civil society, its features, tasks and functions, as well as the possibilities of its creation in Russia in modern conditions is given, the forms of connection between real and potential civil society and its sociological research are shown.

*The essay is 3-4 pages of text.*

*Requirements for the essay:* the work should be done on one side of a standard-sized sheet of paper. On the sides of the sheet leave margins of 30 mm on the left, 15 mm on the right, 20 mm at the bottom and top. It is recommended to use font 14, spacing - 1.5, paragraph indent - 1.25 cm, no indent between paragraphs. All sheets of the essay should be numbered, pages should be marked at the bottom, in the centre.

A student's essay is an independent written work on a topic proposed by the teacher. The aim of the essay is to develop the skills of independent creative thinking and written presentation of one's own thoughts. The essay should contain: a clear statement of the essence of the problem posed, include an independently conducted analysis of the problem and conclusions summarising the author's position on the topic. The essay should be written in a scientific style of speech.

When writing and designing an essay, typical mistakes should be avoided, such as: (1) superficial presentation of the main theoretical issues of the chosen topic; (2) the paragraphs under consideration do not reveal the main aspects of the chosen topic; (3) excessive borrowing, (4) violation of technical requirements for design.

*Control questions for the credit*

Attestation on the discipline takes place in the form of a credit.

The credit is awarded based on the results of the evaluation of the student's written work and individual oral interview on control questions.

Scale of evaluation of written work and individual oral interview -  
"pass or fail."
